- 4. Chair's Report The Chair's verbal report was received: Nick Anderson explained that a long standing member had said that she thought the club was in a good place, which was pleasing to hear. He gave the current membership number as 67 (up from 49 last year) + 7 who have paid and then left the club having sold their van etc. He asked the membership to express views to the cttee after the meeting on a) anything we should spend club funds on? b) should we have different types fo rallies and if so where? Should we attend a festival as a club for example? c) how can we improve? He also asked if any member would be willing to assist Chrisitne to send out van stickers and welcome letters to new members when she is away travelling (2 members subsequently came forward to offer help). He thanked members for their involvement with the club and particularly those who had come forward to book and marshal rallies which is vital to the club going forward.
- 5. General Secretary's Report General Secretary's verbal report was received. Ruth confirmed that the Club holds a valid public Liability Insurance Certificate (which is required at a number of rally sites) and that the Exemption certificates from Natural England and their counter parts in Scotland and Wales are valid. She explained that progress has been made on a new website for the club. A brief has been written, a Zoom meeting has been held with the current web manager and 4 potential new providers have been identified. The committee have approved the brief and have decided that the club shall keep its current logo as it has been in existence since the beginning and we have material with it printed on.

She also explains that the committee has decided to sign up to some membership management software called membermojo. It is cheap to use, seems straightforward and it has a member directory areas where members can opt into string their details with other members. This will also address a member resolution later on our agenda.

6. Treasurer's Report Nigel set out the Treasurer's report which had been previously circulated. The club holds funds as at end March 2022 of £6,852.21. (NB the income and expenditure statement has been confirmed as a correct record by Peter Snowden the club's auditor)
